Subject: Implementation of Barcoding system in Health Care Facility under BMWM Rules-2016.

Dear Sir/Madam,

Kind Attention:- Incharge of Bio-Medical Waste

Bio-medical Waste Management Rules, 2016 notified on 28.03.2016 and as amended till date under the Environment (Protection) Act, 1986, stipulates that it is the duty of every Health Care Facility (HCF) to establish a bar code system for bags or containers containing bio- medical waste (BMW) to be sent out of the premises or place for any purpose. The last date of compliance was **27.03.2019**.

The Bio-medical waste management rules, 2016, clause 4 (i) and clause 5(c) have mandated the implementation of a barcoding system for the tracking of waste from the source of origin up to final disposal.

Central Pollution Control Board (MoEF and CC) has issued the guidelines for Bar Code System for Effective Management of Bio-medical Waste. Point 5 (a) (iii) and 5 (b) (i) of the (CPCB) guidelines state that the CBWTF Operator has to adopt a centralised software system and the access login and password needs to be provided to the Regulatory authorities.

The barcoding so adopted by the HCF's has to be synchronized with central software adopted by the CBWTF to ensure smooth and effective management of Bio-Medical Waste Collection, Transportation and Disposal.

On the basis of criteria specified in BMWM Rules-2016 and CPCB guidelines for providing Barcoding Solutions, our company **M/s Polestar Infosystem** is selected by M/s Biotic Waste Solutions Pvt. Ltd., a CBWTF authorized by Delhi Pollution Control Committee.
