What does a safety department do?

SOP (1) What are the safety measures in Hospital?

SOP (2) What is Hospital safety?

It defines the safety and health care of patients. safety includes free of errors, injuries, accidents, infections and disease spread.

SOP (3) What does a Hospital safety officer do?

The Public Safety Officer assures the Public Safety of the Hospital's buildings and grounds. Protect all employees, patients, visitors or others having legitimate business on Hospital property from harm or loss of personal property. Protect the Hospital's assets from fire, theft, damage or misuse

SOP (4) What is the Patient Safety Rule?

The Patient Safety and Quality Improvement Final Rule (Patient Safety Rule) establishes a framework by which Hospitals, doctors, and other healthcare providers may voluntarily

- Device cleaning, disinfection and sterilization. ...
- Standardizing safety across the healthcare system.
